**Agenda Item 3: Review of Progress of Schemes and Quarterly Progress Reports**

As per the revised guidelines of BADP Quarterly Progress Reports should be submitted scheme-wise to the Department of Border Management latest by 15<sup>th</sup> day of closer of the quarter. The Quarterly Progress Report for the quarter ending 30/09/2009 has been submitted to GoI. The next report for the quarter ending 31/12/2009 is due to be sent before 15/01/2010. The Deputy Commissioners of the border districts have been asked to ensure timely submission of the report.

SLSC may take a view and issue necessary directions.

Revised schemes of Rs 99.50 lac falling within 0-15 km of international border and UCs of Rs 6.00 lac have been submitted to GoI and it has been requested to recoup the amount while releasing the second installment for 2009-10. GoI has been requested to expedite.

SLSC may take a view and issue necessary directions.

#### Agenda Item 5: Baseline Survey

In order to assess the gaps in basic physical and social infrastructure, the Ministry of Home Affairs, GoI is insisting the State Governments for carrying out a baseline survey of border villages. Deputy Commissioner of all border districts have been asked to do the needful but no inputs have been received from any quarter. The Vice Chancellors of four Universities of the State have been requested to give their proposals for conduct of baseline survey along with cost estimates and timeframe.

SLSC may take a view and issue necessary directions.

#### Agenda Item 6: Convergence of Plan Schemes

For the overall development of border areas and to avoid duplicacy, the revised guidelines of BADP envisage that the State Governments prepare a comprehensive plan for border areas i.e. village and block-wise as a part of District Plan by converging various Centrally Sponsored Schemes, flagship schemes of GoI and schemes of the State Government and schemes under BADP by showing fund share of

each component in the baseline expenditure plan. The matter was also discussed in the meeting of SLSC held on 19/08/2009 and the DC's of four border districts were asked to give information but no information has been received from any quarter so far.

SLSC may take a view and issue necessary directions.

#### **Agenda Item 7: Monitoring, Evaluation and inspection of BADP works**

As per the revised guidelines of BADP, the State Government can reserve 1.5% of the allocation made to the state subject to a maximum of Rs 40.00 lac for the purpose of monitoring, training of staff at block level and for evaluation of the BADP, administrative expenditure for preparing the perspective plans of any survey, logistic support (including purchase of vehicles), media publicity etc.

In the meeting of SLSC held on 19/08/2009, DC's of four border districts were asked to take necessary steps in this regard and it was suggested that for third party evaluation GNDU could be engaged. But no such proposal has been received from the districts except district Gurdaspur who has engaged GNDU for this purpose. District Gurdaspur has also proposed a revised scheme of Rs 4.00 lac for carrying out monitoring evaluation which has been submitted to GoI for sanction of funds. However, Deputy Commissioners have appointed Nodal Officers for carrying out monitoring of works done under BADP.

A team of officers of Department of Planning has been formed for carrying out inspection of BADP works. The first round of inspection fixed from 14 December to 26<sup>th</sup> December has been completed. Teams have already undertaken the inspections and submitted their reports.

SLSC may take a view and issue necessary directions.

#### **Agenda Item 8: Preparation of Inventory of Assets and their maintenance**

GoI has asked the State Governments to prepare & submit an inventory of assets created under BADP along with photographs.

A complete list of works done under BADP from 2004-05 onwards has been uploaded on the website of Department of Planning. The same can be viewed at [www.pbplanning.gov.in-schemes-BADP-Assets](http://www.pbplanning.gov.in-schemes-BADP-Assets) created/work done under BADP-Year-District. The DC's have been asked to supply detail of assets created under BADP along with photographs. However no information has been received so far.

As per the revised guidelines of BADP, State Governments may keep a provision not exceeding 15% of allocation made to the State for maintenance of assets created under the BADP subject to the condition that such expenditure can be made only after 3 years from date of issue of completion certificate in respect of the asset. As such the Border Districts are required to prepare a list of works completed, and requirement of funds for maintenance.

SLSC may take a view and issue necessary directions.

**Agenda Item-9: Operationalization of works done under BADP**

It has been observed that though the funds are utilized for the purpose these are allocated but there is a gap in completion and operationalization. The projects completed need to be implemented and made fully operational to achieve the objective of overall development of the border areas.

SLSC may take a view and issue necessary directions.

**Agenda Item:10 Formulation of Annual Action Plan 2010-11**

Government of India has instructed the State Governments to initiate action for the preparation of the Annual Action Plan under the BADP for the year 2010-11, so that the same could be furnished to MHA, Department of Border Management in the Month of April/May 2010. For this purpose the meeting of SLSC is to be convened in the month of February/March 2010.

The Deputy Commissioners have been asked vide letter No. 4/2-PSPB-R.O. (BADP)-2009/ 10672-75 dated 4/12/2009 to prepare the Annual Action Plan 2010-11 strictly in accordance with the revised guidelines of BADP. Districts need to ensure the finally submission of proposals strictly in accordance with the guidelines of BADP. As desired by GoI convergence of various state/Centrally Sponsored Schemes has to be done as the grass root level.
