Sir/Madam,

Please refer to the subject cited above.

- As you are aware that Annual Plan 2007-08 document has been passed by the State Assembly recently alongwith other Budget Documents of the Finance department. In order to avoid unnecessary delay in the release of funds and to ensure that physical and financial targets fixed under various schemes/projects are achieved in a time bound manner, it has been decided that only the following schemes/ projects are required to be sent to the Planning Department for clearance during 2007-08.
  - (i) New State level /Centrally Sponsored Schemes/ Projects;
  - (ii) New Components of State level/Centrally Sponsored ongoing schemes;
  - (iii) Additional requirement of funds under State level/Centrally sponsored Schemes/ Projects;
  - (iv) Creation of new staff, if any.
- Administrative Departments are requested to critically examine the proposals regarding additional requirement of funds in their department (s) before sending it to the Planning Department. Efforts may be made for internal adjustments in the existing schemes of the concerned department(s), as it may not be possible for the State Government to adjust all the additionalities in view of the constraints on the State's resources. It may, therefore, be ensured that only the proposals regarding additional requirement of funds which are of committed nature like salaries, court cases, land compensation etc are sent to the Planning department for approval/clearance.

4. Administrative Departments are, therefore, advised to send the proposals complete in all respects indicating SOE-wise detail with full justification and physical and financial targets fixed for the current year in order to avoid back reference of proposals. These proposals may be sent to the Planning Department for clearance at the earliest.
