2. The Committee can co-opt as member, any expert in the subject or official as the need may be. The Committee can also invite any official/expert as special invitee to the meetings of the SLSC.

3. The term of the Committee shall be for a period of 5 years from the date of issue of notification. The headquarters of the Committee shall be at Chandigarh. The Committee shall meet from time to time and at a place to be decided by the Chairman of the Committee. The Screening Committee shall, however, meet at least once in a year. The functions of the Committee shall be as under:-

- a) To allocate funds to the border districts/blocks as per norms fixed by Government of India and finalize/approve the schemes/work plan proposals of these districts/blocks within the overall allocation/s approved under the Border Area Development Programme by the Government of India.
- b) To issue guidelines/instructions to the concerned border districts for formulation of proposals/projects/schemes for the development of Border Areas.
- c) To assess and monitor the progress of schemes/programmes under the Border Area Development Programme.

4. This supercedes the earlier Notification No.1/1/96-PSPB-RO(BADP)/3687, dated 5<sup>th</sup> April, 2005 on the subject issued by the Department of Planning.
