10.	Secretary, Water Supply & Sanitation, Punjab	Member
11.	Secretary, School Education, Punjab	Member
12.	Economic Adviser, Punjab	Member
13.	Any other Administrative Secretary (Concerned with SDGs)	Member
14.	Director, Planning, Punjab	Member Secretary

3. The functions of the State Level Task Force for Monitoring of Sustainable Development Goals(SDGs) shall be as under:-

- a) Monitoring and Review of the implementation of Sustainable Development Goals(SDGs) in the State;
- b) Review/Strengthen the State Statistical System for SDGs related data flows;
- c) In addition to above, the Task Force may undertake any other action as may be required by NITI Aayog/concerned Ministry at the Central level for guiding/supporting the implementation of SDGs in the State; and
- d) Any other function decided by the Chairman.

4. The Task Force shall meet from time to time and at a place to be decided by the Chairman as per emerging requirements.






