**Subject:- Release of funds under District Level Punjab Nirman Programme for Setting up of Community based Reverse Osmosis Safe Drinking Water Plants in Gidderbaha (Mukatsar) during the year 2007-08.**

2. The Governor of Punjab is pleased to allocate an amount of Rs 250.00 lacs for a pilot project for Setting up of Community based Reverse Osmosis Safe Drinking Water Plants in Gidderbaha, district Mukatsar under the Plan Scheme PM 1.5 "Formulation of District Plan at the District Headquarters" during the year 2007-08 and allows to incur the expenditure on the specified works. The project will be implemented by the Naandi Foundation in collaboration with the TATA Projects Ltd. MoU in this regard shall be signed by the Deputy Commissioner, Mukatsar on behalf of the Government of Punjab.

3. This sanction is issued subject to the Ex-post facto approval from CMM regarding relaxation in para 4 (g) of the guidelines for utilization of funds under Punjab Nirman Programme, issued vide this Department's Memo No. LPD/Allocation/BDI)2005/351-353 dated 11/1/2006 for implementing this project through Private/Voluntary Organizations as a one time exception.

4. This sanction is subject to the following conditions:-

- (i) The expenditure may be met under the Plan Scheme PM1.5 'Formulation of District Plan at District Headquarters' as per the guidelines issued by this Department vide its Memo No. 2/1/PSPB(RO-LPD)/07/4202 dated 30/4/07.
- (ii) Deputy Commissioner in his capacity as Member Secretary of District Planning and Development Board/Committee will maintain the account of releases, utilization of funds etc. He will be responsible for ensuring proper accounting and utilization of funds released under the programme and furnish the Utilization Certificate to the Department of Planning well in time.
- (iii) Project should be completed with these funds as no additional funds would be provided for this project.
- (iv) The cost estimates should be got verified before releasing the funds to the executing Bodies.
- (v) It will be the responsibility of the Deputy Commissioner, Mukatsar to ensure that funds are drawn from the Government Treasury as per actual requirement.

- (vi) The expenditure may be incurred under the Capital Head “5475-Capital Outlay on other General Economic Services-01-District Plan at the District Headquarters-112-Statistics.
- (vii) Reconciliation of the above expenditure with the AG Punjab may be ensured.
