Subject:- Release of funds under District Level Punjab Nirman Programme during the year 2008-09.

Please refer to the subject cited above.

2. The Governor of Punjab is pleased to allocate an amount of Rs. 10.00 Cr (Rupees ten Crore only) under Punjab Nirman Programme under the plan scheme PM 1.5 'Formulation of district plan at the district headquarters – (iv) Punjab Nirman Programme' during the year 2008-09 and allow to incur expenditure on the various development works which are in accordance with the guidelines of Punjab Nirman Programme. An amount of Rs 5.00 Cr will be provided to Municipal Corporation, Amritsar out of these funds. This also includes the share of Special Component Plan.

3. This sanction is subject to the following conditions:-

- (i) The expenditure may be met under the Plan Scheme PM1.5 'Formulation of District Plan at District Headquarters.
- (ii) Schemes will be implemented through Government/Local Body Agencies as may be deemed appropriate by the District Planning and Development Board.
- (iii) Deputy Commissioner in his capacity as Member Secretary of District Planning and Development Board will maintain the account of releases, utilization of funds etc. He will be responsible for ensuring proper accounting and utilization of funds released under the programme and furnish the Utilization Certificate to the Department of Planning well in time.
- (iv) The funds under this programme may be withdrawn from the treasury and expenditure may be incurred after getting the works/schemes approved from Hon'ble Chief Minister, Punjab strictly in accordance with the guidelines of Punjab Nirman Programme issued by this Department vide its Memo No. (LPD/Allocation/BDI)2005/351-353 dated 11/1/2006 and subsequent amendments issued from time to time.
- (v) The expenditure may be incurred under the Capital Head "5475-Capital Outlay on other General Economic Services-01-District Plan at the District Headquarters-112-Statistics.
- (vi) No funds should be provided to Private Institutions/Voluntary Organizations/Religious Bodies.
- (vii) Reconciliation of the above expenditure with the AG Punjab may be ensured.
- (viii) Works/Schemes to be undertaken with these funds should be completed with the available funds as no additional funds would be provided for completing the incomplete works.

- (ix) Utilization Certificates may be obtained from the concerned department/executing agency at the earliest possible.
- (x) The cost estimates should be got approved from the competent authority wherever necessary before releasing the funds.
- (xi) If any amount has already been given/ received from this department or from some other sources for the same purpose, then the funds for such purpose may be drawn to meet the difference of estimated cost from the Government Treasury. This may be ensured from the executing department before releasing the funds.
