**Subject: Release of funds under Punjab Nirman Programme during 2006-07.**

Please refer to the subject cited above.

2. The Governor of Punjab is pleased to allocate an amount of Rs. 10.50 Crore (Rs. Ten crores and Fifty lacs only ) for 'Punjab Nirman Programme' under the Plan Scheme PM 1.5 'Formulation of district plan at District Headquarter' during the current year 2006-07 and allow to incur expenditure on the works to be approved by the DP & DBs District/ areawise distribution of Rs.10.50 crore is given in Annexure-I.

3. The expenditure may be met under the Plan Scheme PM1.5 'Formulation of District Plan at the District Headquarters' strictly in accordance with the following guidelines:-

- i) The expenditure may be incurred only on the works/schemes approved by DP & DB. DP & DBs are authorized to decide the infrastructural works at their own level strictly in accordance with the guidelines already issued by the Planning Department vide its letter dated 11/1/2006 and subsequent amendments issued from time to time. Approval of the State Planning Department is not required for this purpose.
- ii) Schemes will be implemented through Government/Local Body Agencies as may be deemed appropriate by the District Planning and Development Board.
- iii) Deputy Commissioner in his capacity as Member Secretary of District Planning and Development Board will maintain the account of releases, utilization of funds etc. He will be responsible for ensuring proper accounting and utilization of funds released under the programme and furnish the Utilization Certificate to the Department of Planning well in time;
- iv) The monthly progress report for the implementation of the programme will be sent by the Deputy Commissioner to the Department of Planning latest by the 10<sup>th</sup> of the following month in the enclosed performa;
- v) Schemes to be undertaken with these funds should be completed with the available funds as no additional funds would be provided for completing the incomplete works;
- vi) No funds should be provided to Private Institutions/Voluntary Organizations/Religious Bodies.

5. The expenditure may be incurred under the Capital Head '5475-Capital Outlay on other General Economic Services-01-District Plan at the district headquarters' 112 Statistics.

6. It will be the responsibility of the concerned departments/Executing agencies to ensure that funds are drawn from the Government Treasury as per the actual requirement.

7. The cost estimates should be got approved from the competent Authority wherever necessary before releasing the funds to the concerned Departments/Executing Agencies.
