## **PREFACE**

Budget related basic statistics have the important role in policy decisions. The present brochure “State Finances: A Comparison 2004-05” presents some of the basic statistics relating to revenue receipts and revenue expenditure of all the states in India. In this brochure an attempt has been made to compare the revenue receipts from various sources and revenue expenditure incurred on developmental and non-developmental activities during the year 2001-02 and 2002-03 (Accounts) ,2003-04 (Revised Estimates) and 2004-05(Budget Estimates) .The budgetary data used in this report is taken from the Punjab State’s Budget Documents and Reserve Bank of India’s Publication “State Finances: A study of Budgets of 2004-05”.

## **Major highlights of the Report**

1. Receipts of Punjab State from the taxes have been increasing continuously during the period under reference. During 2001-02, Tax receipts were Rs. 4820.23 crore, which increased to Rs. 5711.00 crore in 2002-03, Rs. 6893.64 crore in 2003-04 and Rs. 7876.01 crore in 2004-05 budget estimates.
2. The state tax ratio to Gross State Domestic Product has also been increasing which is a good indicator for economy. This Ratio increased from 6.80 percent in 2001-02 to 8.91 percent in 2004-05.
3. Total Grants from the centre which are provided under Non plan, Plan and Centrally Sponsored Schemes have also been increasing. Amount of these grants which was Rs. 827.00 crore in 2001-02 had increased to Rs.1617.12 crore in budget estimates for 2004-05.
4. Non tax revenue of the State has also been increasing continuously .The non tax Revenue which was Rs.2935.23 crore in 2001-02 had increased to Rs. 6082.90 crore during 2004-05 as per budget estimates. The main contribution in this increase was from interest.
5. The total expenditure in Revenue account has also been increasing .This expenditure had increased from Rs.12709.81 crore in 2001-02 to 19120.90 crore in 2004-05 .The maximum expenditure had been in the Energy Head which increased from 450.68 crore to Rs.2359.91 crore during the same period.

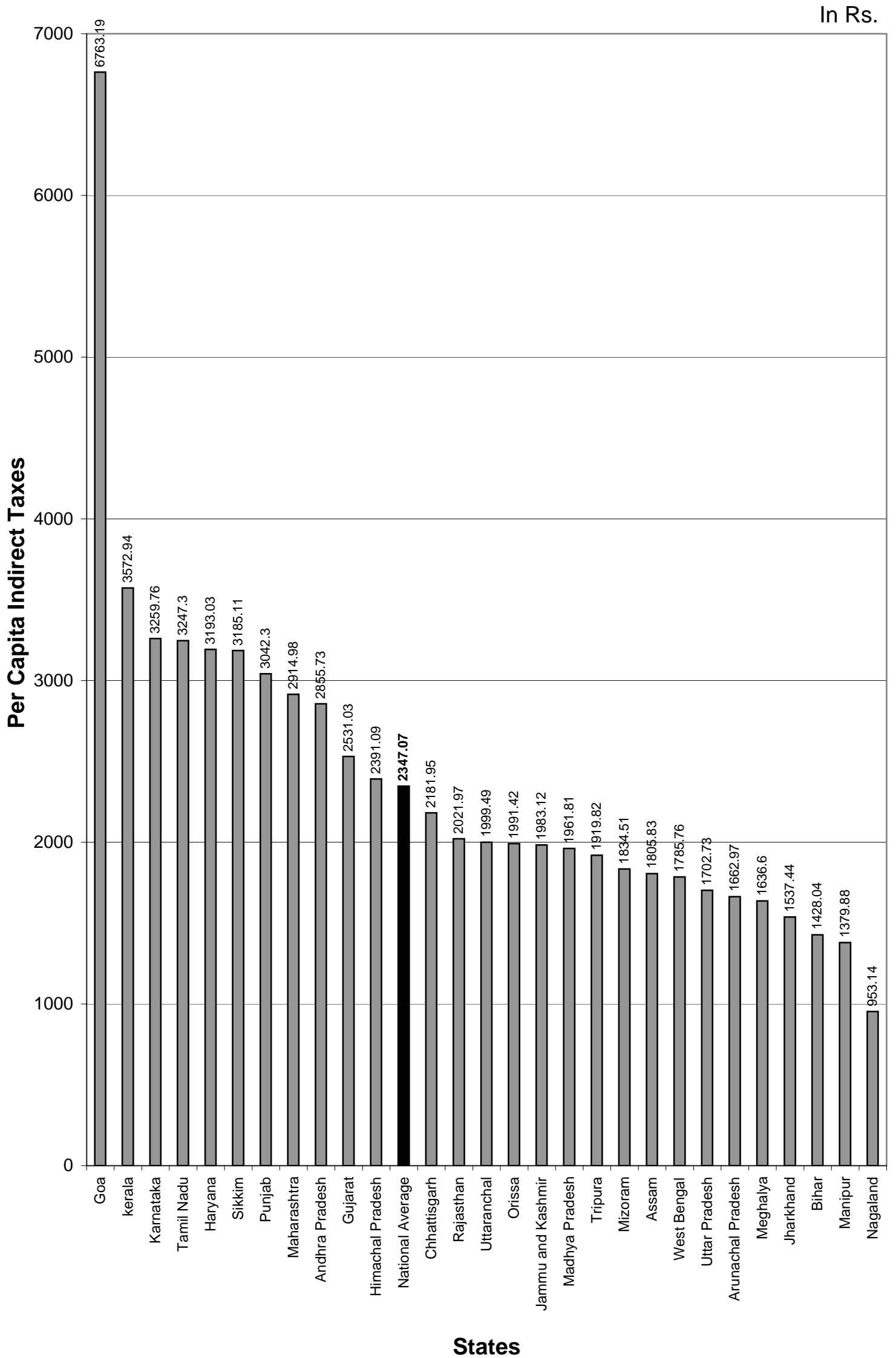


# Per Capita Indirect Taxes in the States (2003-04) Revised Estimates

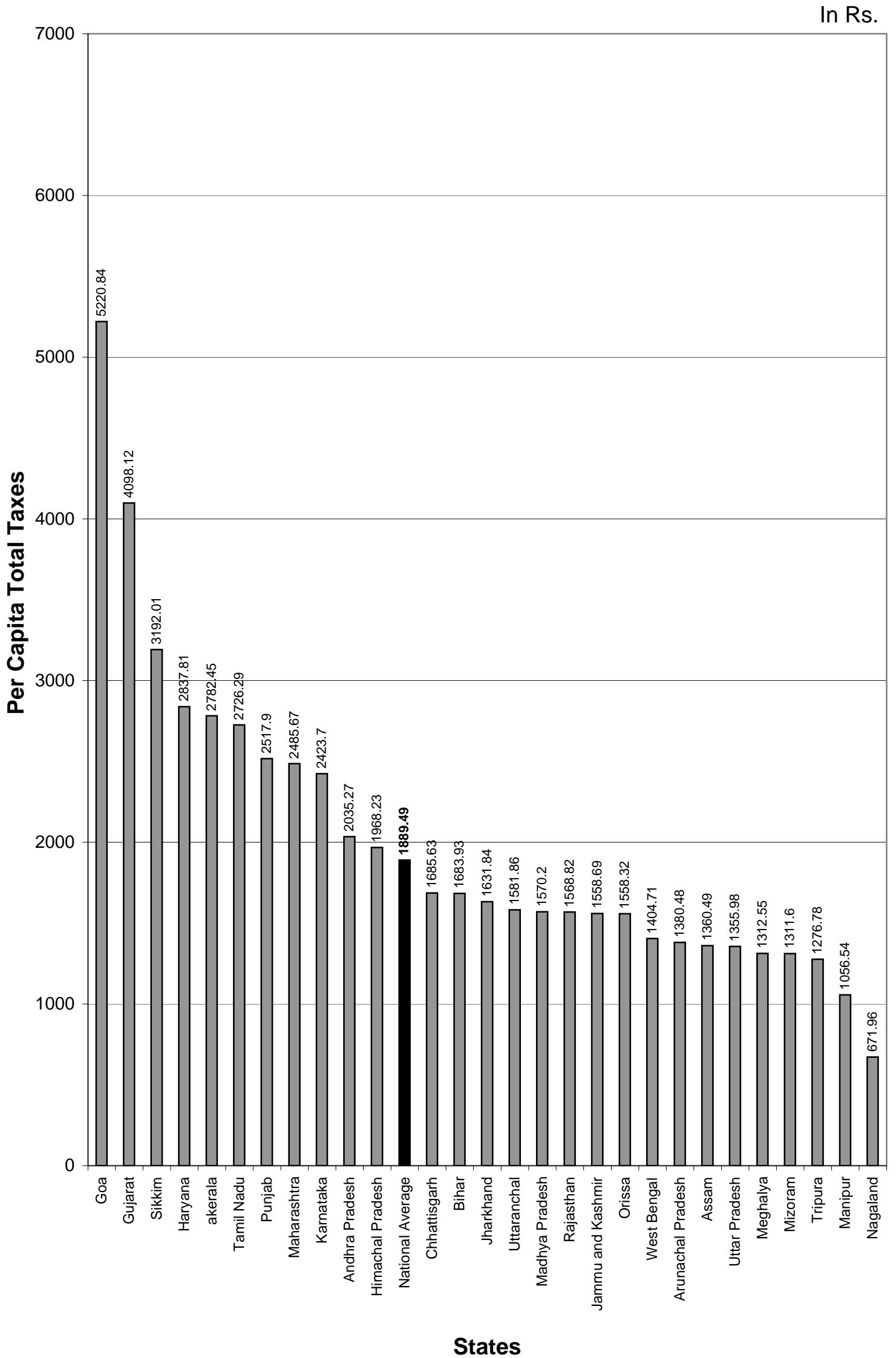

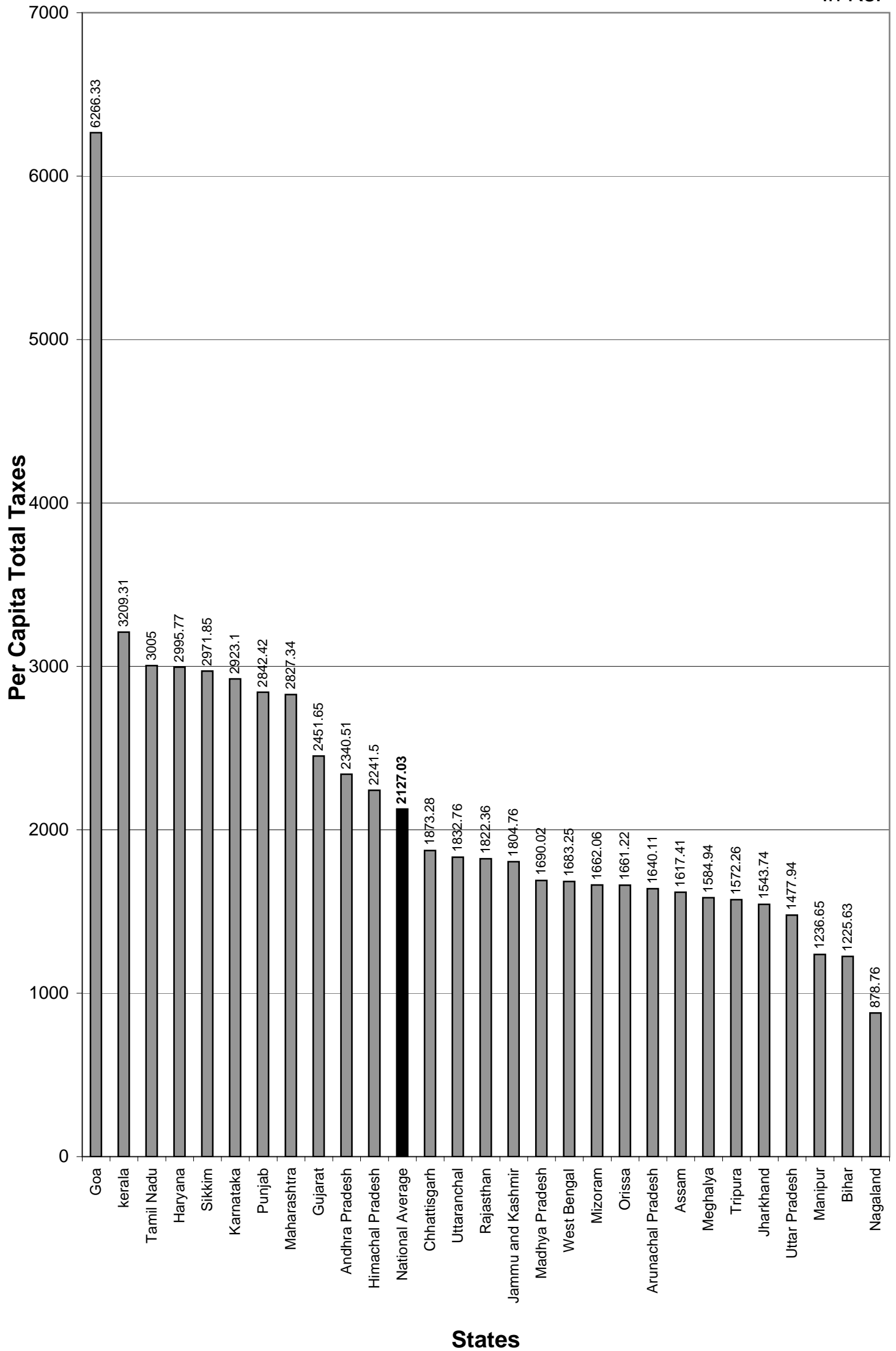

# Per Capita Total Taxes in the States (2002-03) Accounts

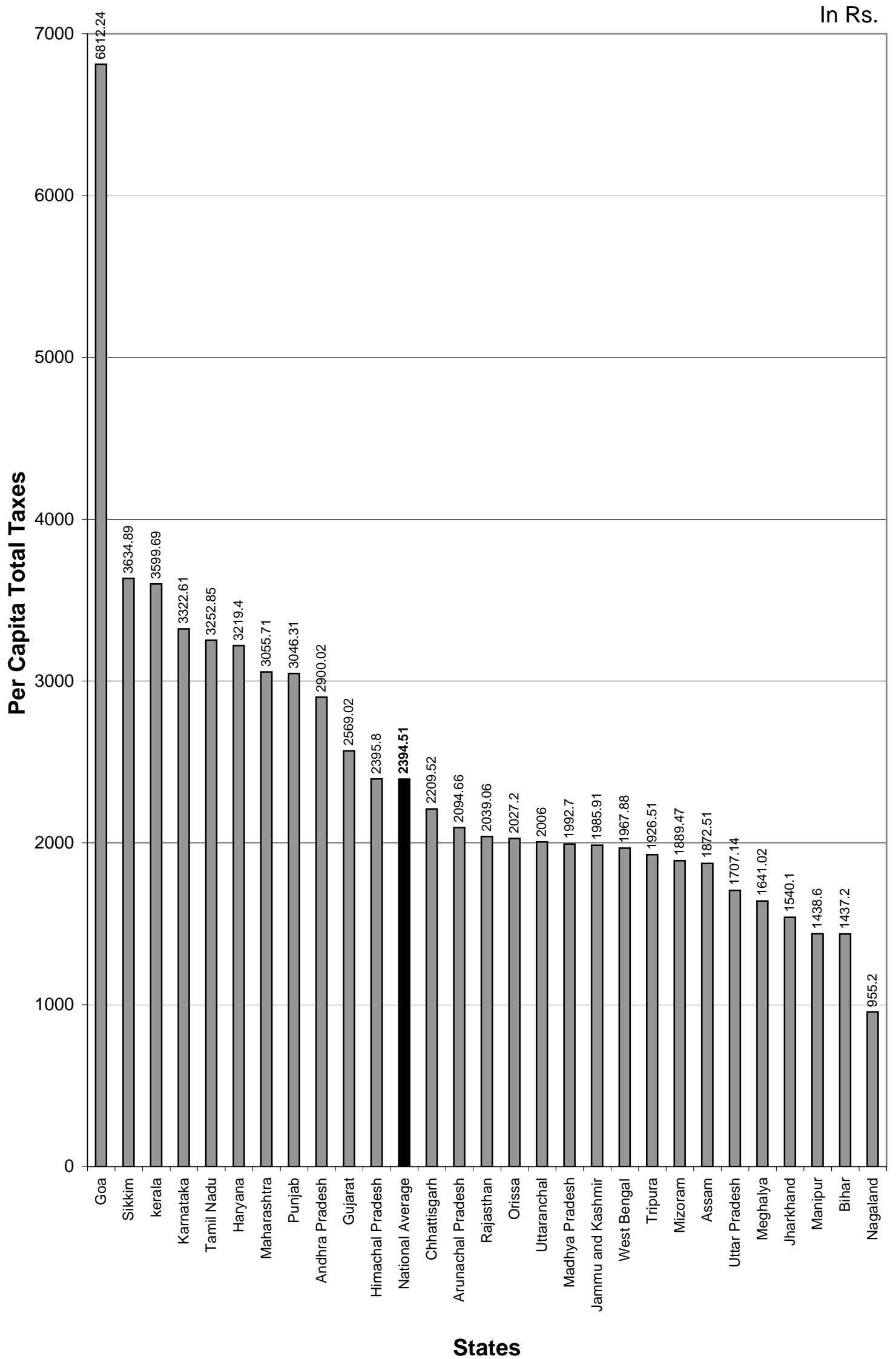


# Per Capita Total Taxes in the States (2003-04) Revised Estimates
