- (i) One Sarpanch for Samiti Member or Zila Parishad Member (The Zila Parishad Member nominated from the block should be one who has his name in the voters list of that block) from each block of the district to be nominated by the State Government on the recommendations of the District Administration.

The present clause 3 is amended as under:-

- (ii) All sitting members of Rajya Sabha who are registered voters in the district can nominate their representative from the district for the respective District Planning and Development Board to attend the meetings in their place from their constituencies.
