In para 2(vii) of the Notification issued vide Deptt. Of Planning (Secretariat Economic Services Division) No. 25/26-PSPB-RO(NGO)-2005/9518 Dated: 26<sup>th</sup> July, 2005, it has been provided that the district level committees will process the applications for grant received from NGOs in accordance with the policy guidelines of the State Government and as per instructions to be issued by the Department of Planning from time to time. In para (VII) of the Policy and Guidelines for Support to Voluntary / Non-Government Organizations in Punjab issued with Govt. of Punjab, Department of Planning (Social Services Division) letter No. PSPB-ARO(W)/99-2000/8623-26 dated 15.10.1999, it was provided that once the Mother NGOs are fully functional, the Administrative Department will place available funds at the disposal of the Mother NGOs for sanctioning grants. It further provides that the Sanction Committee of the Mother NGO will include a representative of the Administrative Department and Planning Department. In para (3) of the instructions issued vide Deptt. of Planning Memo No. PSPB-RO(NGO)-2003/1862 dated 14.3.2003, it was made clear that since Society for Service to Voluntary Agencies (SOSVA) North has already been declared by the State Govt. a Mother Unit for RCH programme in Health & Family Welfare Deptt. Drug De-addiction and other programmes relating to Women and Child Development in the Deptt. of Social Security Women and Child Development, applications from the NGOs for a grant in respect of above noted programmes are not required to be routed through the Deputy Commissioners. It is clarified that the above mentioned instructions continue to hold good and that the selection of NGOs and approval of their schemes in respect of the above mentioned programmes for which SOSVA(N)-Punjab has been recognized as a Mother NGO will continue to be the responsibility of the Sanctioning Committee to be constituted in accordance with the procedure contained in para (VI) of the Policy and Guidelines for Support to Voluntary / Non-Government Organizations in Punjab and applications for these programmes funded by the State Govt. through SOSVA(N)-Punjab as Mother Unit do not need to be routed through the District Level Committees.
