STATE LEVEL SCREENING COMMITTEE FOR BADP**

A notification of the constitution of State Level Screening Committee (SLSC) for Border Area Development Programme was issued vide No.1/1/96-PSPB-RO(BADP)/8103-8115 dated 20/08/2008. Subsequently, vide another notification No.1/1/96-PSPB-R.O(BADP)/2883-2900 dated 25/03/2009 some administrative Secretaries of the line departments were included as members keeping in view the revised guidelines (February 2009) issued by Government of India, Ministry of Home Affairs. In supersession of these notifications the Governor of Punjab is pleased to reconstitute the State Level Screening Committee (SLSC) for Border Area Development Programme as follows: -

2. The Committee can co-opt as member, any expert in the subject or official as the need may be. The Committee can also invite any official/expert as special invitee to the meetings of the SLSC.

3. The term of the Committee shall be for a period of 5 years from the date of issue of notification. The headquarters of the Committee shall be at Chandigarh. The Committee shall meet from time to time and at a place to be decided by the Chairman of the Committee. The Screening Committee shall, however, meet at least twice in a year. The functions of the Committee shall be as under:-

a) To allocate funds to the border districts/blocks as per norms fixed by Government of India and finalize/approve the schemes included in the Annual Action Plan of the these districts/blocks as stipulated in the guidelines within the overall allocation/s approved under the Border Area Development Programme by the Government of India.

b) To issue guidelines/instructions to the concerned border districts for formulation of proposals/projects/schemes for the development of Border Areas.

c) To assess and monitor the progress of schemes/programmes under the Border Area Development Programme.
