Subject: Release of funds of Rs. 100.00 crore for repair/restoration of damaged water courses under district level Punjab Nirman Programme during 2006-07.

2. In supersession of this department's sanction issued vide memo No. (LPD/Allocation)2006/17338 Dated Chandigarh 22nd Nov.,2006 the Governor of Punjab is pleased to reallocate an amount of Rs. 100.00 crore (Rs. hundred crore) under district level 'Punjab Nirman Programme' under the Plan Scheme PM 1.5 'Formulation of district plan at District Headquarter' during the current year 2006-07 for repair/restoration of damaged water courses in 10 districts of the State and allow to incur expenditure on the works identified by the State Irrigation Department/Punjab State Tubewell Corporation. District wise distribution of Rs.100.00 crore is given below:-

3. The expenditure may be met under the Plan Scheme PM1.5 'Formulation of District Plan at the District Headquarters' strictly in accordance with the following guidelines:-

- i) The expenditure may be incurred only on the works/schemes identified by the State Irrigation Department/Punjab State Tubewell Corporation;
- ii) Works will be implemented through Punjab State Tubewell Corporation or any other agency found suitable and selected by the District Planning and Development Boards.
- iii) Deputy Commissioner in his capacity as Member Secretary of District Planning and Development Board/Committee will maintain the account of releases, utilization of funds etc. He will be responsible for ensuring proper accounting and utilization of funds released under the programme and furnish the Utilization Certificate to the Department of Planning well in time;

- iv) The monthly progress report for the implementation of the programme will be sent by the Deputy Commissioner to the Department of Planning latest by the 10th of the following month in the performa already circulated to them.
- v) Funds can be spent through farmers associations/user associations under technical supervision of PSTC.

5. The expenditure may be incurred under the Capital Head '5475-Capital Outlay on other General Economic Services-01-District Plan at the district headquarters' 112 Statistics.

6. It will be the responsibility of the concerned departments/Executing agencies to ensure that funds are drawn from the Government Treasury as per the actual requirement.

7. The cost estimates should be got approved from the competent Authority wherever necessary before releasing the funds to the concerned Departments/Executing Agencies.
