**Subject:- Release of funds of Rs. 100.00 crore for repair/restoration of damaged water courses under District Level Punjab Nirman Programme during 2006-07.**

This is in continuation of Memo No. (LPD/Allocation)2006/17338 dated 22<sup>nd</sup> November, 2006 vide which a sum of Rs. 100.00 crore was distributed for the 9 districts for repair of water courses.

2. Condition of 4 (v) says that no funds will be provided to private agencies. The purpose is that no money be spent on private assets. Water courses are the property of farmers and these were constructed by PSTC through government funds and therefore there is no bar against spending the funds through farmer associations/users association under the technical supervision of PSTC.

3. It is, therefore, clarified that money can be spent through the users association.
