**Subject : Utilisation and Disbursement of Funds under PM -10 "State Level Initiatives-Punjab Nirman Programme".**

Kindly refer to the subject cited above.

2. In pursuant to the guidelines for utilisation of funds under "Punjab Nirman Programme" issued vide Memo No. (LPD/Allocation/BDI)2005/351-357 dated 11<sup>th</sup> Jan., 2006, and subsequent inclusion of additional permissible infrastructure development works vide Memo No 2/1-PSPB-DD(LPD)-2021/3490-3497 dated 18-05-2021, the procedure of utilisation & disbursement of funds envisaged in Para 4(e), 4(f), 4(g) and 4(h) of guidelines dated 11<sup>th</sup> January, 2006 have been modified with the approval of Competent Authority, to substitute the existing Paras of the guidelines 2006, with the following substituted Paras:-

(a) Para 4 (e) : All works under the Punjab Nirman Programme shall be proposed by the Additional Deputy Commissioner (Dev)/Additional Deputy Commissioner (Urban Dev), before a District Level Committee duly constituted for this purpose. The District Level Committee shall comprise of:-

1. Deputy Commissioner..... Chairperson
2. All Commissioners of the Municipal Corporations  
Situated in the District ..... Member
3. Additional Deputy Commissioner (Dev)..... Member
4. Additional Deputy Commissioner(Urban Devpt)..... Member
5. District Development and Panchayat Officer..... Member
6. Dy. Economic & Statistical Adviser..... Member Secretary

The District Level Committee will consider and approve the proposals of works placed before it.


(b) Para 4 (f) : The Deputy Commissioner will accord administrative and financial sanctions for the proposals approved by the District Level Committee.

(c) Para 4 (g) : The works to be undertaken under the Punjab Nirman Programme will be implemented through Government Body/PRI/ULBs or as may be deemed appropriate by the Deputy Commissioner, and as per the guidelines of respective Departments".



- (d) Para 4(h) : The Deputy Commissioner will ensure prompt release of funds to the implementing agencies or bodies, and in addition will maintain proper accounts, utilisations of funds, and carry out audit of the same within one year of the expenditure having been incurred.

The modified guidelines may be noted and necessary action may be taken accordingly.


