2. The Apex Committee can associate any Administrative Secretary or Officer or any other expert as special invitee as may be required from time to time.
3. The Committee shall meet from time to time and at a place to be decided by the Chairman of the Apex Committee. The functions of the committee shall be as under:-
- a) To provide overall guidance and guidelines for involvement of the NGOs in development work in Punjab.
  - b) To review the physical/financial performance of the concerned Administrative Department for promotion of role of the NGOs in development works and to take remedial steps for removing bottle necks, if any ;
  - c) Any other function as decided by the Chairman.

4. The non-official expert called as special invitee in the meeting will be entitled for TA and DA equivalent to the Grade-I officers of the State Government. The TA and DA in such cases shall be payable from the scheme PM 1.10 'Assistance to NGO's'.

5. The term of the committee shall be for three years.
